

LAB IQ

An interactive dashboard that allows users to view laboratory performance metrics.

Eliminates manual processes and increases efficiency, helping laboratories make informed business decisions. Laboratories can view and evaluate test volumes, ordering patterns, and turnaround times. Reference labs can evaluate these metrics by client to monitor performance and ensure high customer satisfaction.

DATA MINER

Allows you to query the database and export information, assisting with patient outcome studies required by many insurance carriers.

Users can define database queries for specific data combinations. For example, a facility may run a query to extract the males over 40 years old with a PSA result greater than 4 ng/mL.

CLIENT SERVICES

This powerful tool, designed for reference laboratories, assists in supporting your customers.

Client contact information is stored in the Client Services option for easy access. Your customer support staff will be able to rapidly open calls, update existing calls, and view communication history with outreach clients.
