

## Third Party Licensing Agreements & Terms and Conditions

## ADDITIONAL TERMS AND CONDITIONS APPLICABLE TO webCoder

These additional Terms and Conditions are applicable to webCoder, as licensed to you by CompuGroup Medical, Inc. ("CGM"). CGM is a licensed reseller for MedAssets Net Revenue Systems, LLC, and the American Medical Association (the "AMA"). These additional Terms and Conditions are hereby incorporated by reference into that certain agreement between you and CGM to license webCoder (the "Agreement"), as if fully set forth therein. Except as otherwise noted, capitalized terms used in these additional Terms and Conditions have the same meaning given to them in the Agreement.

- 1. Your license to the webCoder and the Current Procedural Terminology (CPT®) content ("CPT" or the "File") contained therein is for the current year's File as indicated on Exhibit A to the Agreement licensing webCoder to you. Your license to webCoder and the File contained therein is non-transferable, non-exclusive, and co-extensive with CGM's license from MedAssets, and is for the sole purpose of your internal use of CPT within the United States in the English language.
- Your access to updated CPT content in webCoder is dependent on continuing contractual relationships between CGM and MedAssets, and between MedAssets and the AMA, or between CGM and the AMA or another third party vendor who is licensed to distribute CPT.

Your license prohibits you from using, publishing, distributing via the Internet or other public computer based information system, creating derivative works of, transferring, selling, leasing, or licensing or otherwise making available to any unauthorized party webCoder, or a copy or a portion of webCoder. You may not use, copy, or modify webCoder or any copy, modification or merged portion or version of webCoder, in whole or in part, in any other manner except as expressly provided for in these terms and conditions. ## U.S. Government Rights

- 10. The AMA is an intended third party beneficiary of your agreement to these terms and conditions for the purpose of enforcing at law and at equity all rights against you. Nothing contained in these terms and conditions will be deemed to constitute a joint venture, partnership or agency between parties. You acknowledge that you have read these terms and conditions, understand them, and agree to be bound by them. You represent you have authority to agree to and accept these terms and conditions on behalf of yourself or your organization, as applicable. You agree that it these terms and conditions are the complete and only agreement regarding your license and use of CPT which supersedes any proposal or prior agreement, oral or written, and any other communications between us relating to your license and use of CPT. The delay or failure to assert a right hereunder will not constitute a waiver of that right or excuse a subsequent failure to perform under these terms and conditions. You agree to take all steps necessary, by instruction, agreements or otherwise, to ensure compliance with these terms and conditions by your employees and agents.
- 11. In the event a provision of these additional Terms and Conditions is determined to violate any law or is unenforceable, the remainder of these additional Terms and Conditions will remain in full force and effect.
- 12. You may not assign any rights herein without the prior approval of the AMA. Any attempted assignment will be null and void.
